We prefer authors to use Word processor, Times New Roman,12 pt at the main text. They also should follow the heading and some other writing formats mentioned following to make easier responsibilities of the Journal layout editors and proofreaders.

Heading 1 – Main Heading Level (in Front Page)

Heading 2 – subheading

Heading 3 – subheading

Heading 4- subheading.

Normal – all paragraph text that doesn't include abstract, quotation, headings or references.

Quotation – quotes that are longer than three lines or 40 words should appear as a separate indented paragraph.

Tables- Tables should be placed in text exactly where it should be in the published paper.

Figures/Graphics. Figures/graphics should be formatted as camera ready document type such as jpg, gif etc.
